Article 1 - Legal provisions

Article 2 - The processing of personal data

2.1. Your personal data is collected. Personal data is understood to mean: all information about an identified or identifiable natural person; as identifiable is considered a natural person who can be identified, directly or indirectly, with name by means of an identifier such as a name, an identification number, location data, an online identifier or one or more elements characteristic of the physical, physiological, genetic, psychological, economic, cultural or social identity.

Article 3 - Purpose of the processing

We do not just collect your personal data. Your personal data is processed for:

Article 4 - Registration of personal data

Your personal data are registered in an (electronic) register.



Article 5 - Your rights with regard to your data

5.1. Pursuant to Article 13 paragraph 2 sub b GDPR, everyone has the right to inspect and correct or deletion of his personal data or restriction of processing concerning him, as well the right to object to the processing and the right to data portability. 5.2. Any request to do so must be accompanied by a copy of a valid one proof of identity, on which you have put your signature and stating the address where you can be contacted. Within 1 month of the submitted request, you will receive response to your request. Depending on the complexity of the requests and the number of requests, this period may be extended by 2 months if necessary.

Article 6 - Legal obligations

In case of violation of any law or regulation, of which the data subject is suspected and for which the authorities need personal data collected by the administrator, turn into provide it to them after an explicit and reasoned request from those authorities, after which these personal data are therefore no longer under the protection of the provisions of this privacy statement.
